**OPTIONS REGARDING TRAFFIC CITATIONS IN MUNICIPAL COURT**

**DRIVER'S SAFETY COURSE:**

Must enter a plea in writing of No Contest or Guilty; may use this form  
Must return this form to request DSC on or before appearance date along with court cost of \$103.00 and proof of insurance  
Must have a valid Texas Driver's License (NOT AN OPTION FOR CDL LICENSE)  
Must not be exceeding speed limit by more than 24 mph  
Must not have completed a DSC in last 12 months preceeding the date of your citation  
Must provide copy of driving record - form provided by Court

**DEFERRAL:**

You must contact the office of the Municipal Court, Judge Shelburne, 806-272-7586

**IF YOU ARE A MINOR, YOU MUST BE ACCOMPANIED BY YOUR GUARDIAN TO SEE THE JUDGE.**

**IF YOU FAIL TO RESPOND TO THIS COURT BY THE APPEARANCE DATE SHOWN ON THE CITATION, EITHER IN PERSON OR BY PHONE, AN ADDITIONAL CHARGE MAY BE FILED AGAINST YOU FOR VIOLATING YOUR WRITTEN PROMISE TO APPEAR, AND A WARRANT MAY BE ISSUED FOR YOUR ARREST. \$50.00 FOR EACH WARRANT WILL BE ADDED. IF YOU LIVE OUT OF STATE, YOUR DRIVER'S LICENSE WILL BE SUBJECT TO SUSPENSION ACCORDING TO THE NON-RESIDENT VIOLATION COMPACT.**
